

RESOLUTION NO. 2025-046

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF CORAL SPRINGS, FLORIDA, RECOGNIZING THE HUMANITARIAN IMPACT OF THE OCTOBER 7, 2023 ATTACKS AND AFFIRMING A COMMITMENT TO PEACE AND NEUTRALITY; AUTHORIZING AND DIRECTING THE CITY CLERK TO TRANSMIT THIS RESOLUTION TO THE APPROPRIATE PARTIES; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on October 7, 2023, a series of violent attacks and subsequent conflicts in the region of Israel and Palestine resulted in significant loss of life, injury, and suffering among both Israeli and Palestinian civilians; and

WHEREAS, the City of Coral Springs acknowledges the profound human toll of these events, including the deaths and injuries of innocent people, the displacement of families, and the ongoing trauma experienced by communities on both sides; and

WHEREAS, the City Commission values the principles of compassion, humanity, and respect for all individuals, regardless of nationality, ethnicity, or background; and

WHEREAS, the City Commission seeks to promote peace, understanding, and dialogue while maintaining neutrality in international conflicts, recognizing that local communities may include individuals with ties to both Israel and Palestine; and

WHEREAS, the City Commission condemns all forms of violence against civilians and supports efforts toward a peaceful resolution that respects the dignity and rights of all people; now, therefore

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL SPRINGS, FLORIDA.

SECTION 1. The foregoing recitals contained in this Resolution are incorporated herein by reference.

SECTION 2. The City Commission hereby recognizes the humanitarian impact of the October 7, 2023 attacks and affirms a commitment to peace and neutrality.

SECTION 3. The City Clerk is hereby authorized and directed to transmit this Resolution to the appropriate parties.

SECTION 4. Effective Date. This Resolution shall take effect upon its adoption.
